

TERMS OF USE

Effective February 10, 2016

PLEASE READ THE TERMS OF USE CAREFULLY.

1. ACKNOWLEDGEMENT AND ACCEPTANCE.

a. These Terms of Use (these “**Terms of Use**”) govern your access and use of Insight Medical Data Services LLC (“**Insight**”) online products and services available through its mobile application, **QCDRapp** (together with its related websites, including <https://www.abgreporting.com> collectively, the “**Site**”). The Site is restricted to subscribers for whom Insight provides login credentials (each, a “**User**”). For the purposes of this Agreement, “**you**” or “**your**” shall refer to you as a User of the Site.

b. CAUTION: PLEASE READ THE FOLLOWING TERMS OF USE CAREFULLY. BY ACCESSING AND USING THE SITE YOU AGREE THAT YOU HAVE READ AND UNDERSTOOD AND AGREE TO BE BOUND BY THESE TERMS OF USE, INCLUDING, WITHOUT LIMITATION, THE PRIVACY POLICY [HTTPS://ABGREPORTING.COM/PRIVACYPOLICY.PDF](https://abgreporting.com/privacypolicy.pdf). IF YOU ARE NOT WILLING TO BE BOUND BY THESE TERMS OF USE, DO NOT USE THE SITE. YOU REPRESENT TO US THAT YOU ARE EIGHTEEN (18) YEARS OF AGE OR OLDER. IF YOU ARE UNDER THE AGE OF 18, YOUR PARENT OR LEGAL GUARDIAN MUST AGREE TO THESE TERMS OF USE ON YOUR BEHALF IN ORDER FOR YOU TO ACCESS AND USE THE SITE.

c. The Site is controlled and offered by Insight from the United States of America. Insight makes no representations that the Site is appropriate or available for use in other jurisdictions. If you are a non-U.S. resident and you access the Site, you do so at your own risk and are responsible for compliance with local laws and regulations. You may not access, download, use or export the Site or any Content (as defined below) in violation of U.S. export laws or regulations, or in violation of any other applicable laws or regulations.

2. PRIVACY POLICY. Any confidential information provided by you in connection with your use of the Site, including, without limitation, any Registration Data (as defined below) or other personally identifiable information, will be treated in accordance with Insight’s Privacy Policy [HTTPS://ABGREPORTING.COM/PRIVACYPOLICY](https://abgreporting.com/privacypolicy). Except as expressly described in the Privacy Policy, Insight will not disclose any personally identifiable information about a User unless authorized by that User or unless Insight is required to do so by law or in the good faith belief that such action is necessary to: (a) conform with applicable laws or comply with legal process; (b) protect and defend the rights or property of Insight; or (c) enforce these Terms of Use. Your access and use of the Site constitutes your agreement to the Privacy Policy.

3. LICENSE GRANT.

a. Subject to these Terms of Use, Insight hereby grants you a non-exclusive, nontransferable, nonsublicenseable, limited right and license during the Term (as defined below) to access and use the Site and/or the products and services available through the Site (collectively, “**Licensed Products**”) solely in accordance with any Documentation therefor and solely for your non-commercial personal or internal business use; provided, however, that only Users have the right to access and use the Site and the Licensed Products. “**Documentation**” shall mean any and all Licensed Product specifications, user manuals and guides, training materials, technical information and other documentation and materials associated with the Licensed Products that are provided by Insight to you together with the Site or such Licensed Products. References to Licensed Products in these Terms of Use shall include the Documentation. Except as set forth in this paragraph, no other right or license of any kind is granted by Insight to you hereunder with respect to the Licensed Products. Any updates to Licensed Products provided by Insight hereunder shall be deemed part of such Licensed Products and shall be subject to these Terms of Use.

b. Unauthorized access to or use of the Site or the Licensed Products, or the telecommunications facilities or mobile device used to deliver the Site and the Licensed Products, is a breach of these Terms of Use and is a violation of law.

c. You shall not, and shall not cause or permit any third party to, except as otherwise expressly permitted herein or by prior written consent of Insight: (i) reverse engineer, adapt, translate, prepare derivative works from, disassemble, decompile, modify or change any portion of the Site or the Licensed Products; (ii) remove or alter any copyright, trademark, or other proprietary notices, legends, symbols or labels appearing on or in the Site or the Licensed Products; (iii) use the Site or the Licensed Products for any purpose other than in accordance with the terms and conditions of these Terms of Use, including, without limitation, for any public or commercial purpose, or any unlawful or unauthorized use or purpose or in violation of any third party rights; (d) copy any ideas, features, functions or graphics of the Site or the Licensed Products; (e) transfer, sell, resell, give, distribute or sublicense the Site or the Licensed Products to any third party; (f) use the Site or the Licensed Products in any service bureau arrangement or to provide a data extraction service

to third parties; (g) use the Site or the Licensed Products in any way that deviates from the Documentation; or (h) grant any security interest in the Site or the Licensed Products. In the event of any violation of this paragraph, and in addition to any other remedies available to Insight, Insight may immediately terminate your access and use of the Site.

d. In addition to the foregoing, you will protect all Site content (the “**Content**”) from unauthorized copying or use. Modifications of, additions to, or deletions from the Content are strictly prohibited. Except as specifically permitted in these Terms of Use or in any other agreement between you and Insight, you shall not, directly or indirectly, (i) transfer, sell, sublicense, rent or lease the Content; (ii) circumvent any encrypted data or gain access to more materials or data than was licensed or use the Site in any manner which violates these Terms of Use or any applicable laws; (iii) copy, reproduce, disclose, distribute, display, perform, publish, adapt, create derivative works of, translate, or otherwise modify any Content, or permit any third party to engage in any of the acts proscribed in clauses (i) through (iii). You agree not to remove or alter any copyright or other legal notices contained on or in the Content. Reproduction of the Content in any form or by any means, including, but not limited to, information storage and retrieval systems, recordings and re-transmittals, use in any timesharing, service bureau, bulletin board or similar arrangement or public display without Insight’s written permission is forbidden. Any special rules for the use of certain software and other content accessible through the Site may be included elsewhere within the Site, otherwise provided to you in connection with your use of the Site or contained in another written agreement between you and Insight, and are incorporated into these Terms of Use by reference.

e. The Site and Content are protected by copyright and other United States and foreign intellectual property and related laws. As between you and Insight, title to the Site and all of the Content remains with Insight. Using, copying or storing any Content other than for non-commercial, personal use is expressly prohibited without prior written permission from Insight or the applicable copyright holder. All rights not expressly granted herein are reserved by Insight.

4. USER ACCESS. The Site is made available by Insight, for a fee, to Users that register with Insight, either electronically or pursuant to a written agreement with Insight, for the right to access and use such resources. Users shall pay the fees specified at the time of registration for the use of the Site and the Licensed Products and the Content provided thereby and therein (collectively, the “**Restricted Resources**”). Restricted Resources contain confidential, nonpublic information, and are intended only for the use of the individual or entity that has been specifically authorized by Insight to view such information. Accordingly, Insight reserves the right to limit access to the Restricted Resources to individuals and entities who meet the qualifications imposed by us. In order to use any Restricted Resource, a User must: (a) provide certain current, complete, and accurate information about such User on the applicable registration form (“**Registration Data**”); (b) maintain and update the Registration Data as required to keep information current, complete, and accurate; (c) provide all equipment, including, without limitation, a mobile device, tablet or computer necessary to establish an Internet connection; (d) provide for such User’s own access to the Internet; and (e) pay any fees associated with such access. Insight retains the right to terminate a User’s account and a User’s rights to use any Restricted Resource if any Registration Data provided by the User is untrue, inaccurate, not current or incomplete, or if Insight has reasonable grounds to believe that any Registration Data is untrue, inaccurate, not current or incomplete, or if User otherwise breaches these Terms of Use, including, without limitation, the Privacy Policy. Upon expiration of the Term or termination of a User’s access and use of the Site, the User’s right to use the Restricted Resources specified therein shall immediately cease.

Users access the Restricted Resources through a combination of a unique user name (“**Username**”) and a password (“**Password**”) provided by Insight to a User in connection with User’s subscription to the Site. Each User is responsible for maintaining the confidentiality of his, her or its own Username and Password. Furthermore, each User is entirely responsible for any and all activities which occur under his, her or its Username and Password. Each User agrees to immediately notify Insight of any unauthorized use of the Restricted Resources to which such User is granted access or such User’s account or any other breach of security known to such User. Although Insight will not be liable for losses caused by any unauthorized use of a User’s account, such User may be liable for the losses of Insight or others due to such unauthorized use. Each User is solely responsible for (a) any charges, damages, or losses that may be incurred or suffered as a result of such User’s failure to maintain the strict confidentiality of his, her or its Username and Password; and (b) promptly informing Insight in writing of any need to deactivate any Username and Password due to security concerns.

5. USER CONDUCT. Users may have the opportunity to post, transmit or otherwise provide documents, files, information, data, questions, comments or other content on the Site (collectively “**User Generated Content**”). You are responsible for any material or User Generated Content that you post, transmit to or otherwise provide through the Site. Insight does not control any User Generated Content. Insight has the right, but not the obligation, to monitor any content posted, transmitted or otherwise provided by Users on the Site. Insight neither endorses nor is responsible for the accuracy or reliability of any User Generated Content posted, transmitted or otherwise provided on the Site. - g. transmit or upload to the Site, or use in connection with the Site, any software, device or routine that contains viruses, worms, time bombs, Trojan horses or other computer programming routines that may interfere with or attempt to interfere with, damage or in any way intercept the normal operation of the Site, or take any action that imposes an unreasonable load on our computing platform;
- h. post information on or download information from the Site unless you have all rights and authority necessary to do so;
- i. falsify or delete any attributions, legal or other proper notices or proprietary designations or labels of the origin or source of software or other material available on the Site or through the use thereof;
- j. attempt to "crack," "hack," "bomb," manipulate or otherwise gain unauthorized access to other User accounts, Insight servers, Insight software, or any areas of the Site not intended for your access; or
- k. harvest, mine or otherwise collect or store personal information about others, including, without limitation, e-mail addresses and the content of User profiles.

Violation of any of the above may, at any time without prior notice, result in a warning, temporary limit or suspension or immediate termination of your account or your access to the Site, reporting of your conduct to authorities, or legal action, as may be appropriate in the sole discretion of Insight. You acknowledge that Insight is not responsible for and does not assume any liability for (i) any action or inaction by Insight with respect to any User conduct, User communication or User Generated Content on the Site, or (ii) Users' acts or omissions in connection with the use of the Site, including, without limitation, with respect to the aforementioned activities. - d. information reasonably sufficient to permit the service provider to contact you, such as an address, telephone number and an electronic mail address;
- e. a statement that you have a good faith belief that use of the material in the manner complained of is not authorized by the copyright owner, its agent, or the law; and
- f. a statement that the information in the notification is accurate and, under penalty of perjury, that you are authorized to act on behalf of the owner of an exclusive right that is allegedly infringed.

EACH PARTY ACKNOWLEDGES AND AGREES THAT THE LIMITATIONS OF LIABILITY SET FORTH ABOVE ARE A CONDITION OF THE OTHER PARTY ENTERING INTO THESE TERMS OF USE.

c. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATION OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES. ACCORDINGLY, SOME OF THE ABOVE LIMITATIONS MAY NOT APPLY TO THE USER. NOTWITHSTANDING THE FOREGOING, INSIGHT'S LIABILITY IN JURISDICTIONS WHICH DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES SHALL BE LIMITED TO THE FULLEST EXTENT PERMITTED BY LAW BUT SHALL, IN NO EVENT, EXCEED \$100.00.

13. INDEMNIFICATION. You hereby consent to receive communications from Insight electronically. Insight may communicate with you by email or by posting notices on the Site. You agree that all agreements, notices, disclosures and other communications that Insight provides to you electronically satisfy any legal requirement that such communications be in writing.

16. MODIFICATION, WAIVERS, INTEGRATION, SEVERABILITY. Insight may modify, add or remove any portion of these Terms of Use at any time and from time to time. Notification of such changes to these Terms of Use will be posted on the Site and will be effective immediately thereafter. Your continued use of the Site after the posting of the modified Terms of Use thereon constitutes your agreement to abide and be bound by such terms, as modified. Should you object to any modification, your sole recourse is to terminate your use of the Site. These Terms of Use may not otherwise be modified, except in a writing signed by both parties. Insight reserves the right to modify or discontinue the Site (or any portion thereof), temporarily or permanently, with or without notice to you, and is not obligated to support or update the Site.
